AFFIDAVIT ON ABSTENTION FROM VOTING**

I, Brian Livingston, a member of the City Council of the City of Frisco, Texas, submit this Affidavit in accordance with Chapter 171 of the Texas Local Government Code and/or the City of Frisco Code of Conduct, and hereby on oath state the following (place an "X" by the statement that applies):

**A. Business Entity**

I and/or one or more persons related to me\* have the following substantial interest in a business entity, and action on the agenda item identified above will have a special economic effect on the business entity that is distinguishable from the effect on the public:

- Ownership of 10 percent or more of the voting stock or shares of the business entity or ownership of either 10 percent or more or \$15,000 or more of the fair market value of the business entity, and.
- Funds received from the business entity exceed 10 percent of gross income for the previous year.

**B. Real Property**

I and/or one or more persons related to me\* have an interest in real property with a fair market value of \$2,500 or more that is involved in the agenda item identified above or located within 200 feet of that property, and it is reasonably foreseeable that action on the item will have a special economic effect on the value of the property, distinguishable from the effect on the public.

*\*For purposes of Sections A and B of this Affidavit, a "person related to me" refers to a person within the first degree of consanguinity (parent or child, natural or adoptive) or the first degree of affinity (spouse, spouse's child, mother-in-law, father-in-law, daughter-in-law, son-in-law). In cases of divorce or death, if a child is living, the marriage is considered as continuing, even after divorce or death, for purposes of this Affidavit.*

**C. Other Conflict**

- Action on the agenda item identified above would benefit the economic interests\*\* of one or more of the following persons or entities:
- (1) myself and/or one or more persons related to me, \* and/or
  - (2) my client or customer, and/or

- (3) my employer, and/or
- (4) a business entity in which I or a person related to me\* holds an economic interest, and/or
- (5) a business entity that is an affiliated business or a partner of a business entity in which I or a person related to me\* holds an economic interest, and/or
- (6) a business entity or nonprofit entity in which I serve as an officer or director or in any other policy-making position, and/or
- (7) a person or business entity from whom I, directly or indirectly, have received and not rejected an unsolicited offer of employment or business opportunities or have accepted or received and not rejected an unsolicited offer of employment.

*\*For purposes of Section C of this Affidavit, a "person related to me" refers to a person within the second degree of consanguinity (parent or child, natural or adoptive, sibling, grandparent, grandchild) or the second degree of affinity (spouse, spouse's child, mother-in-law, father-in-law, daughter-in-law, son-in-law, brother-in-law, sister-in-law, spouse's grandparent, spouse's grandchild). In cases of divorce or death, if a child is living, the marriage is considered as continuing, even after divorce or death, for purposes of this Affidavit.*

*\*\*For purposes of Section C of this Affidavit, "economic interests" refers to a legal or equitable interest in real property, personal property or contractual rights with a value of more than \$50,000.*

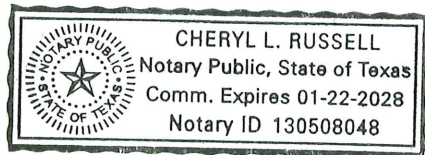
